Letter from the Executive Directors

Dear friends,

We are writing to share key developments from ASAP this year. ASAP reached an incredible

milestone: we now serve over 1 million asylum seekers across the United States! Our members' vision

has been a guiding light during a turbulent time for immigrants.

Amid this year's upheaval, ASAP's how-to legal resources became a source of clarity and stability for

millions. Updated daily, these resources kept immigrants informed about changes to the immigration

system and were viewed more than 10 million times! At the same time, expert immigration attorneys

answered thousands of one-on-one questions at ASAP's digital legal help desk.

We successfully defended access to work permits for asylum seekers, mobilizing employers and keeping

383,000+ immigrants in the workforce. After members told us they were falling out of the workforce due

to processing delays, ASAP mounted a campaign, working alongside nonprofits, faith-based groups,

labor unions, city and state governments, and the business community. As a result, the government au-

tomatically extended work permits for hundreds of thousands of immigrants for 540 days!

We were proud to successfully defend birthright citizenship and the Constitution. When birthright

citizenship came under threat, ASAP members mobilized to defend the rights of all children. Members

led a major federal lawsuit and spoke out in hundreds of news stories, winning temporary protections

for all children born in the United States.

As we close out this year, we extend our gratitude to all the supporters and members who make ASAP

possible. It's a privilege and an honor to be in community with you all. Together, we can defend the rights

of 1 million people working for a better life in a new home.



Monica's Story

When Monica thought about the government's attempts to end birthright citizenship, the stress of the future made her lose sleep. "It truly brings so much uncertainty not knowing what's going to happen to your baby," said Monica, a pregnant ASAP member living in South Carolina.

In late 2024, Monica took part in ASAP members' collective decision-making process, deciding that a top priority would be defending birthright citizenship, should it come under attack.

In January, the government announced it would try to end birthright citizenship. ASAP members and staff jumped into action, filing a lawsuit in federal court to protect the Constitutional rights of millions of parents and children in the United States. Monica and other ASAP members also spoke out in more than 350 news stories — in outlets large and small.

Now, ASAP members have won temporary protections for all babies born in the United States, and we are continuing to fight for a permanent, positive result.

"If we can do this for our child's rights, we will do it," said Monica.
