Re: DHS Docket No. USCIS-2024-0002, Comments in Response to Temporary Final Rule Entitled Temporary Increase of the Automatic Extension Period of Employment Authorization and Documentation for Certain Employment Authorization Document Renewal Applicants

Dear Chief Nimick:

The Asylum Seeker Advocacy Project ("ASAP") respectfully submits the following comment to the temporary final rule, *Temporary Increase of the Automatic Extension Period of Employment Authorization and Documentation for Certain Employment Authorization Document Renewal Applicants*, 89 Fed. Reg. 24,628 (Apr. 8, 2024) (DHS Docket No. USCIS-2024-0002; CIS No. 2767-24) ("the TFR" or "the Rule").

I. Summary of the Argument

ASAP applauds DHS for issuing the TFR. The Rule will prevent hundreds of thousands of unnecessary and harmful lapses in work authorization caused by delays in renewing asylum seekers' employment authorization documents ("EADs" or "work permits"). Through the TFR, DHS has offered meaningful stability and protection to many asylum seekers and other immigrant workers, as well as their employers, their communities, and the U.S. economy.

Although the TFR is an important first step, ASAP urges DHS to take additional steps, as the Rule does not fully address the severe harms that flow from delays in adjudicating work permit renewals. By DHS's own estimate, over 260,000 individuals

(including over 155,000 asylum seekers) will experience unnecessary gaps in their work authorization, even with the TFR, unless the agency makes additional changes. See 89 Fed. Reg. at 24,647, 24,659. Additionally, as explained below, the TFR will only have the impact DHS intends if employers and state Departments of Motor Vehicles (DMVs) understand and adhere to the TFR's 540-day auto-extension.

ASAP respectfully recommends DHS implement the following changes to mitigate harm to applicants:

- (1) DHS should make the TFR permanent;
- (2) DHS should lengthen the auto-extension period to 730 days; and
- (3) USCIS should prioritize work permit processing backlogs, take additional steps to alleviate confusion around the TFR amongst employers and DMVs, and expand the number of immigrants covered by the TFR.

Additionally, ASAP lays out reasons why DHS should make it easier for asylum seekers and other immigrants to comment directly on rule changes, including by accepting comments in languages other than English, beginning with accepting comments in Spanish.

II. ASAP's Interest in the Proposed Rule

The Asylum Seeker Advocacy Project ("ASAP") believes that asylum seekers can make great change by standing together. ASAP has over 640,000 members – asylum seekers from 175 countries – living in all 50 states and U.S. territories. ASAP provides members with legal and community support.

By creating self-help resources and answering legal questions, ASAP staff members have helped hundreds of thousands of asylum seekers apply for work permits, renew their existing work permits, and seek fee waivers and immigration relief. As the largest membership organization of asylum seekers in the United States, ASAP is uniquely positioned to offer insight about the TFR based on member feedback. ASAP members (and ASAP as an organization) have a strong interest in preventing unnecessary lapses in work authorization and documentation, including via the TFR and other much-needed reforms. Moreover, many ASAP members are essential workers and work in a range of industries like medicine and truck driving, which continue to face labor shortages.

ASAP members' suggestions, comments, and feedback are summarized in the arguments that follow. Overall, ASAP members expressed concern about work permit processing delays and recommended changes to the TFR to improve access to employment authorization. Below are comments we found representative of ASAP members' feedback on the TFR.

"Oh my god, this is amazing news! I am so happy for myself and all the people in this situation."

"I feel [insecure] because at any moment something could happen, but if my work permit could be permanent, it would reassure me and make me feel safe."

- ASAP member from Haiti

"The delays on work permit renders a lot of famil[ies] homeless because the sustainability of families depends on it. Parents have to work in other to take care of their families. If the government can make the 540 days permanent it will be great"

- ASAP member from Cameroon

"It is so stressful . . . especially when you are thinking of changing a job[.] [T]here is that point you have to prove [to] the employer that [you] can legally work[.] I think it would be better for the government to make . . . longer extensions more than 540 days or they should let someone work until a new work permit is renewed as long as they send in the[ir] renewed work papers on time. Thanks!"

- ASAP member from Uganda

"Make the previous work permit valid until a decision on the renewal application has been made"

- ASAP member from Bangladesh

"The government should make the longer work permit permanent until their asylum is decided by the government. This is good relief for both the asylum seekers and the government."

- ASAP member from Ethiopia

"Notification of extension letters should be sent to individuals so that we have evidence to show our employers."

- ASAP member from Nigeria

"It's important for [the purposes of] updating [our] [d]river['s] [l]icense and showing [it to our] employer. Also it causes stress. They should send us [] written proof with [the] extension date."

"I think that extending the validity date of work permits would provide more peace of mind and time for renewals to be carried out."

III. The TFR Will Bring Relief to Hundreds of Thousands of Asylum Seekers

This TFR has been great news for asylum seekers, as it will ensure asylum seekers and other immigrants do not fall out of the workforce. ASAP members responded with enthusiasm to the TFR, agreeing that the 540-day work permit extension is urgently needed.

Asylum seekers applying for work permit renewals constitute the vast majority of individuals currently impacted by USCIS's work permit processing delays. By DHS's own estimates, asylum seekers account for about 80% of the approximately 800,000 work

permit renewal applicants who would risk imminent lapses in their work authorization without the benefit of the TFR. See 89 Fed. Reg. at 24,634. Moreover, "[c]ontinuous employment authorization during the pendency of an asylum application is vital for asylum seekers in the United States, given their particularly vulnerable position." *Id.* at 24,653.

As the TFR explains, loss of work authorization poses unique harms to asylum seekers, who are "often" in "precarious economic situations . . . as a result of fleeing persecution in their home countries." *Id.* at 24,644. And "[t]he situation for asylum applicants is especially dire because of the significant time that [they] must wait to become employment-authorized in the first place" after applying for asylum. *Id.* Asylum seekers need work permits "to access housing, food, and other necessities," as well as "medical care" and "mental health services" relating to the harms they have survived, and "legal counsel in order to pursue their claims." *Id.* at 24,645.

Furthermore, work permits serve vital purposes beyond work authorization. For many asylum seekers and other immigrants, a work permit is the only government-issued photo identification available. This means that work permits are critical for asylum seekers and other immigrants to apply for driver's licenses, secure apartment leases, access banking, obtain basic utilities, enroll in healthcare coverage or school, and obtain other necessities.

For all these reasons, ASAP applauds DHS's decision to acknowledge and prevent the "significant adverse consequences for applicants, their families, and their employers" that would have materialized if not for the TFR. 89 Fed. Reg. at 24,645.

IV. Response to DHS Question #1: Permanently Lengthen the Work Permit Extension

DHS asked the public: "[w]hether DHS regulations should be revised to permanently lengthen the period of the automatic extension to up to 540 days for employment authorization and/or EAD validity for eligible renewal applicants." 89 Fed. Reg. at 24,628. In response, <u>ASAP recommends that DHS permanently lengthen the work permit extension period.</u>

ASAP members have reported that a permanent automatic 540-day work permit extension will provide increased security and alleviate significant anxiety about USCIS's backlog and processing delays. Both this comment and other ASAP member comments

included below encourage DHS to make the work permit extension permanent. Additionally, though the TFR issued a temporary work permit extension of 540 days, ASAP members would also welcome a permanent 730-day work permit extension. See infra Section V.

There are several reasons why DHS should take permanent action on lengthening the work permit extension period.

First, a permanent rule will prevent unnecessary lapses in work authorization and identification that could occur after the current TFR expires. See 89 Fed. Reg. at 24,674. There is no guarantee that the work permit backlogs will be addressed by the time the TFR expires, and there is always the possibility of unforeseen circumstances causing further backlogs. As a result, DHS should issue a permanent rule now, and take action to shorten the work permit extension period once USCIS has eliminated the work permit renewal backlog. At that time, the agency can promulgate a new rule to return to 180-day automatic extensions or any other period warranted by the circumstances. Such an approach would avoid the hardship and uncertainty that would be caused if the TFR sunsets before the agency has fully addressed the work permit renewal backlog crisis.

Second, a permanent rule would potentially save DHS time. DHS has now had to expend resources twice by issuing two temporary final rules providing 540-day extensions. As ASAP and ASAP members warned in 2022, "[i]f USCIS has not addressed the work permit renewal crisis by October of 2023, another TFR will be needed to ensure that hundreds of thousands of immigrants do not once again fall out of the workforce." A permanent rule would allow DHS to allocate its limited resources to other priorities, including strategies to tackle the backlog itself.

Third, as ASAP members explain in their comments, a longer work permit extension being permanent "would provide long-term predictability for applicants," their families, and their employers. *Id.* Applicants and their families will not feel pressured to apply for early or premature work permit renewals to benefit from the longer work permit extension period.

Fourth, employers will benefit from a permanent work permit extension, as it will mean less likelihood of employees losing work authorization in the coming years. This long-term increased work permit extension will create greater predictability of business operations and staffing.

Fifth, unforeseen developments may complicate DHS's ability to issue a third temporary final rule if conditions require it. For instance, DHS's policy priorities may shift away from mitigating the harms caused by lapses in employment authorizations due to processing delays and operational challenges. A permanent 540-day (or longer) extension would make it significantly less likely that asylum seekers and other immigrants lose their work authorization in the coming years due to a work permit processing backlog crisis.

V. Response to DHS Question #2: Issue a Longer Work Permit Extension

DHS's second specific question for comment is "[w]hether a different permanent extension period should be implemented, for some or all applicants covered by the automatic extension provision on either a temporary or permanent basis." 89 Fed. Reg. at 24,628. <u>ASAP strongly recommends that DHS issue a work permit extension of at least 730 days and begin to contemplate implementing an automatic renewal process.</u>

ASAP members expressed great concern that the TFR clearly states that the 540-day work permit extension is not long enough to prevent immigrant workers from losing work authorization due to work permit processing backlogs. Although the 540-day work permit extension is an important step, ASAP respectfully urges DHS to take further action to prevent unnecessary lapses in the work authorization of asylum seekers and other immigrants stuck in work permit processing backlogs.

A. Lengthen the Work Permit Extension to 730 days

The 540-day work permit extension is simply not long enough to ensure that asylum seekers and other immigrants will not be forced out of the workforce due to processing delays. USCIS projects that because of spikes in processing times expected in August 2024, 260,327 individuals (including 155,730 asylum seekers in work permit category (c)(8)) could experience gaps in work authorization even with the benefit of the TFR. See id. at 24,659, Table 6B. In contrast, as the agency acknowledges, "a large part of" this population would experience no gaps in work authorization under a 730-day auto-extension. Id. at 24,647.

ASAP recommends that DHS implement a work permit extension period that is at least 730 days (if not longer) for asylum seekers and immigrants whose work permit renewal applications are pending. A 730-day auto-extension would protect many of the 260,327 individuals who are currently projected to lose work authorization beginning in November of 2025 despite the TFR. See 89 Fed. Reg. at 26,647, 59. Implementing a longer auto-extension benefits these applicants and their families, as well as the many stakeholders who depend on them, including employers and local communities.

The TFR provides a few justifications for declining to implement a 730-day extension, including: (1) DHS's decision to prioritize the near-term needs of applicants, their families and employers; (2) DHS's concerns about confusion among employers; (3) public familiarity with the normal 180-day extension or the 2022 temporary final rule's 540-day extension; (4) uncertainties in data projections; and (5) the agency's view that an extension of 540 days better supports its legal claim of "good cause" to forego notice-and-comment rulemaking. See id. at 24,647-48. However, none of these stated reasons are compelling given that the alternative is the threat of over 260,000 immigrants falling out of the workforce beginning in 2025.

Addressing only the near-term needs. DHS stated it has prioritized the near-term needs of applicants. But issuing a 730-day work permit extension would provide near-term relief, while also ensuring that immigrants do not fall out of the workforce in 2025 if DHS takes no further action. Engaging in solving problems that are projected to become a crisis within 2 years is not long-term planning. Furthermore, ASAP members who believe they could be among the 260,000+ immigrants to fall out of the workforce due to backlogs are already worried – as are their employers. Acting now to issue a 730-day work permit extension would ameliorate that stress and uncertainty, which is in and of itself an immediate, near-term need.

Risk of confusion. DHS hopes to minimize the risk that employers may be confused. This is a laudable goal. However, it is important to remember that employers and immigrant workers have dealt with significantly more confusing work authorization instructions, including having to check the ever-changing date on the federal register for individuals with Temporary Protected Status (TPS) related to the preliminary injunction order of the U.S. District Court for the Northern District of California in Ramos, et al. v. Nielsen, et al., No. 18-cv-01554 (N.D. Cal. October 3, 2018). This example is evidence that employers and immigrant workers can handle changes to work authorization validity dates. It is also clear that employers and immigrant workers are motivated to learn more about work permit extensions, as they are the primary beneficiaries.

To mitigate any potential confusion, DHS could adopt a 730-day extension for all immigrants subject to both the temporary work permit extension issued in 2022 as well as this TFR. This would ensure that all immigrants subject to work permit extensions have a 730-day extension. Additionally, the agency could minimize employer confusion by improving and updating its helpful Employment Authorization Document Automatic Extension Calculator (the "Calculator") to provide employers with a definitive answer as to the expiration date of a work permit,² creating a short frequently asked questions ("FAQ") document for employers, providing applicants with receipt notices that accurately reflect work permit extension lengths, and taking additional, reasonable steps discussed below to educate employers. See infra Section VI.

But the possibility of employers losing their immigrant workforce would be the most confusing and stressful outcome for employers. As a result, any potential confusion will be outweighed by the benefits; applicants and employers will welcome the opportunity to work and employ with increased certainty and stability.

Familiarity. DHS also notes that employers, applicants, and the public are now familiar with the ordinary 180-day extension and the 2022 temporary final rule's 540-day auto-extension. But that familiarity took time. And if anything, the 2022 rule has increased awareness that the agency has the authority to adjust automatic extension periods when necessary. When the 2022 rule was published, employers, applicants, and the public were only familiar with the 180-day extension under the previous rules. Thanks to USCIS's public-facing resources, stakeholders could understand that the 180-day extension had been converted to a 540-day extension. Similarly, if USCIS provides additional guidance, as discussed below, it need not be difficult for applicants, employers, or the public to understand a 730-day work permit extension. See infra Section VI.

Uncertainties. The TFR also opines that the uncertainty of USCIS's data projections and the possibility of future policy and operational changes counsel in favor of focusing solely on imminent needs. But, in fact, these uncertainties weigh in favor of a longer extension that better accounts for the possibility that work permit processing delays increase in the future. Furthermore, there is no harm in having a 730-day work

permit extension put into place even if USCIS can process more work permit renewal applications faster than previously projected.

A 730-day or longer auto-extension will avert potential harms to over 260,000 immigrants, their families, employers, and communities. Moreover, many of these applicants are asylum seekers who already experience high levels of uncertainty caused by financial hardship, processing delays in their underlying immigration applications, and the possibility that shifting policy priorities will endanger their ability to work as their expiration dates grow near. Instead of taking a wait-and-see approach that exacerbates this uncertainty, USCIS should act now to provide these applicants with confidence that they will not face lapses in their work authorization.

"Good cause" exception. Finally, ASAP respectfully disagrees with any suggestion that a 540-day extension falls more squarely within the "good cause" rulemaking exception than a longer auto-extension. See 89 Fed. Reg. at 24,654. To be sure, the "limited duration and scope" of a temporary final rule is relevant in determining whether it falls within the good cause exceptions in 5 U.S.C. § 553. But just like this TFR, a 730-day auto-extension would be a limited measure, it would not "make[] additional categories [of workers] eligible for the automatic extension," and it would be limited to applicants "who are currently in the United States and authorized to work" and "merely seeking renewal of their employment authorization and/or EADs." 89 Fed. Reg. at 24,653-54. In addition, a 730-day auto extension would still be appropriately tailored to "address the potential lapses that are imminent"—specifically, the lapses that are projected to occur as soon as next fall. See id. at 24,654. Moreover, any delay in agency action is impracticable, and "the grave situation that these third parties face is not the result of their own actions and is beyond their control." Id. at 24,651; see also Nat'l Fed'n Emps v. Divine, 671 F.2d 607 (D.C. Cir. 1982).

In sum, ASAP asserts that a 730-day work permit extension is the single most critical change DHS should take, including if the agency needs to prioritize this solution over others. See supra Section IV. As we laid out above, a system under which applicants receive 730-day work permit extensions is within DHS's authority (including under the "good cause" exception) and will result in significant benefits to applicants, employers, and the public, while freeing USCIS from significant operational pressures.

B. Explore an Automatic Renewal Process for Asylum Seekers

DHS should begin to explore the possibility of implementing an automatic work permit re-extension or renewal process for asylum seekers with pending asylum cases. Specifically, ASAP recommends that after issuing a 730-day work permit extension, DHS begin to explore automatically renewing asylum seekers' work permits if their asylum cases are still pending at the time their work permits are set to expire. Alternatively, DHS could also explore automatically re-extending asylum seekers' work permits if their renewal applications are still pending. USCIS has the authority to renew or extend work permits for any interval it chooses.³ And there are compelling reasons for the agency to exercise that authority.

First, an automatic renewal process would dramatically relieve pressure on USCIS to process work permit applications. As DHS explains in the TFR, in 2023, it had to reassign officers, hire new staff, and spend more time on work permit applications to comply with court deadlines and keep up with an increase in applications. See 89 Fed. Reg. at 24,635-36. Despite these efforts, USCIS has been unable to reduce processing times and "avoid imminent and near-term lapses." *Id.* at 24,636. By implementing an automatic re-extension process, DHS could relieve much of the burden of having to timely process applications facing a risk of lapse. And by going further—that is, by implementing an automatic work permit renewal process for asylum seekers whose asylum applications remain pending—DHS could eliminate the need to adjudicate hundreds of thousands of Form I-765 renewal applications each year. This, in turn, would help address "the repeatedly mentioned pain point and most known bottleneck of the agency—EAD processing."⁴

Second, USCIS would not necessarily have to lose out on fee collection of work permit renewal applications if the agency instituted an auto-renewal process for work permit applications. Instead, the agency could consider an automatic work permit

renewal process that permits fee collection but does not require a new application be submitted.

Third, an auto-renewal process would pose little risk that ineligible asylum seekers would be granted renewal work permits. USCIS's overall approval rate for work permit renewals in fiscal year 2020 through 2021 was 92.7%. See 87 Fed. Reg. at 26,641. For asylum seekers, the figure was even higher—96.8% —and as explained in the next section, many of the remaining 3.2% of applications were rejected due to USCIS error or minor, technical applicant errors.

VI. Response to DHS Question #3: Implement Additional Solutions to Mitigate Work Permits Expiring

DHS's third specific question for comment is "[w]hether other solutions should be considered to mitigate the risk of expiring employment authorization and/or EAD validity for some or all applicants covered by the automatic extension provision." 89 Fed. Reg. at 24,628. ASAP has laid out suggestions on how the agency can: (A) prioritize addressing the work permit backlog; (B) take additional steps to prevent confusion over the longer work permit extension; and (C) expand the work permit extension to cover a greater number of immigrants.

USCIS should implement solutions to ensure that asylum seekers and other immigrants do not fall out of the workforce. First, USCIS should implement several operational and policy changes that address the work permit processing backlog, including: increasing staffing for work permit renewal processing; expanding e-filing; streamlining Form I-765; and updating data-tracking systems. Second, ASAP recommends that USCIS prevent employer and DMV confusion about the TFR by: reissuing receipt notices; explain the 540-day extension to employers, amending Form I-9; conducting public engagements with additional stakeholders, simplify and improve USCIS existing resources, update USCIS Calculator and website, and do more outreach to state DMVs. Lastly, USCIS should broaden the TFR to include applicants whose renewal applications were received by the agency after the expiration dates on their work permits.

A. Prioritize Addressing Work Permit Backlogs

USCIS must continue to speed up processing of work permit applications, including renewal applications, and resolve delays that have plagued the agency in recent years. More broadly, ASAP urges USCIS to prioritize processing all renewal applications before the expiration of the applicant's auto-renewal period. To address the work permit backlogs, ASAP members recommend four changes in particular: (1) increasing staffing for work permit renewal processing, (2) expand e-filing, (3) streamline Form I-765, (4) updating USCIS's tracking system.

1. Increasing Staffing for Work Permit Renewal Processing

First, USCIS should prioritize increasing the number of staff working on eliminating the work permit backlog (including for renewals). USCIS can implement this solution immediately by using the cost savings from the other recommendations in this section, as well as the \$34,374,000 that Congress recently appropriated for the purpose of reducing work permit processing backlogs.⁶

Due to timing, the TFR does not take into account the \$34,374,000 in funding appropriated by Congress earlier this year. As a result, we ask DHS to lay out the agency's plans for operationalizing these funds now, in response to comments. Given the volume of the backlog and the risk that over 260,000 immigrants will needlessly lapse out of work authorization, see 89 Fed. Reg. at 24,647, USCIS should use these funds to do everything possible to alleviate work permit processing delays – and process as many work permits as possible.⁷

ASAP recommends that USCIS use creative solutions to spend the \$34,374,000 and get work permit processing under control. We understand that it may be difficult to hire adjudicators given both labor shortages in the U.S. and the lack of guarantee of long-term funding from Congress for work permit processing. As such, ASAP recommends that USCIS authorize overtime; hire contractors to take away some preparation and administrative tasks from government officials; appeal to USCIS retirees to return part-time to the agency to adjudicate work permits; and seek out the

assignment of detailees from other government agencies, offering reimbursements to other agencies for reassigning their staff to work permit processing.

USCIS has proven that when it prioritizes reducing backlogs, it can achieve remarkable results—as it did during fiscal year 2023, when it processed 10 million naturalization cases, nearly halving naturalization processing times, and effectively eliminating the backlog of naturalization applications. ASAP recommends that USCIS make eliminating the longstanding work permit backlog (including the backlog of renewal applications) its number one priority for the remainder of calendar year 2024.

2. Expand E-Filing

USCIS should expand e-filing by making it possible for asylum seekers and other immigrants to e-file fee waiver requests; and thus, in turn, e-file their accompanying work permit applications. Further, USCIS should allow e-filing of all categories of work permit applications, not just a select few. Enabling asylum seekers to e-file work permit applications "reduc[ed] the operational costs associated with paper applications such as scanning, manual data entry, and shredding," "allow[ing] resources to be used elsewhere" and "increas[ing] operational efficiencies for USCIS." 89 Fed. Reg. at 24,643. USCIS should increase efficiencies again by expanding e-filing to include fee waiver requests, which would ensure more immigrants file work permit applications online as well. As such, getting the fee waiver application online for e-filing should be a priority associated with reducing the work permit backlog. The current system effectively limits e-filing to individuals who are able to pay the filing fee, which prioritizes renewal applicants with more resources over those who already face economic hardship (and, on top of that, now risk losing their work authorization).

3. Streamlining the Form I-765

ASAP members have repeatedly urged the government to resume accepting the 2017 version of the Form I-765, which is two pages long instead of seven pages.¹⁰ Some

of the questions on the current Form I-765 are not necessary for USCIS to adjudicate work permit eligibility. Indeed, the form was initially lengthened in part to implement harmful regulatory barriers to work permits that USCIS has since rescinded. A longer and more complex form causes confusion, increases the possibility of mistakes, and leads to delays in submitting applications. From the agency's perspective, too, receiving and reviewing lengthier forms takes more time and increases the likelihood of mistakes, exacerbating adjudication and processing delays. Reverting to the shorter Form I-765 will mitigate those delays, including for renewal applications.

4. Updating USCIS's Data Tracking System

USCIS should also begin updating its internal systems so it can track work permit expiration dates and prioritize adjudicating renewal applications for individuals whose work permits are about to expire. According to the TFR, "there is currently no system-based way to assign work based on expiring employment authorization." 89 Fed. Reg. at 24,643. But even if it would take one year to make this possible, see *id.*, if the agency begins these updates now, they will have a system up and running before the longer work permit extension begins to lapse next fall, see *id.* at 24,661. A prioritization tracking system would not only benefit individuals who are covered by the TFR, but it would also benefit the hundreds of thousands of people not covered, such as recipients of the Deferred Action for Childhood Arrivals (DACA) or people who apply for a work permit renewal after their work permit has expired.

The TFR suggests that such prioritization "could incentivize more applicants to file their renewal EAD applications close to the expiration of their EADs," *id.* at 24,643, but this concern is overblown. As ASAP members' comments illustrate, asylum seekers, like all work permit applicants, need authorization to work and are motivated to have valid EADs.

B. Preventing Confusion Among Employers and DMVs

The TFR's 540-day auto-extension will prevent approximately 800,000 renewal applicants and their communities from experiencing severe harm through no fault of their own—but only if employers and state DMVs understand it. DHS has expressed concern that some employers and DMVs may be confused about precisely when an individual's

work permit expires. ASAP respectfully urges the agency to take several straightforward steps to ensure that the TFR's promise is realized in the real world, not just in theory.

Specifically, ASAP recommends USCIS implement the following solutions to prevent employer confusion: (1) reissue receipt notices, (2) explain the 540-day extension to employers, (3) amend Form I-9, (4) conduct public engagements with additional stakeholders, (5) simplify and improve USCIS resources about the work permit extension, (6) update the USCIS Calculator and USCIS website, and (7) do more outreach to state DMVs.

1. Reissue Receipt Notices

First and foremost, USCIS should reissue Form I-797C receipt notices to all applicants eligible for the 540-day auto-extension, but who received a Form I-797C receipt reflecting a 180-day auto-extension. This will avoid any confusion caused by having a Form I-797C with inaccurate or outdated information.

After the 2022 temporary final rule was promulgated, many ASAP members faced challenges in accessing the 540-day extension because they had not received clear receipt notices stating that there was a 540-day extension in place. Under the new TFR, the automatic 540-day extension is available to eligible renewal applicants who timely filed on or after October 27, 2023, and whose applications were still pending as of April 8, 2024.

Since the TFR was issued in April of 2024, ASAP staff have received many questions from ASAP members asking what to do if their employers or the DMV do not believe they received the 540-day extension because their receipt notice states they are subject to a 180-day work permit extension. As such, there is still much work the agency should be doing to eliminate confusion.

Alternatively, USCIS should allow individuals to request replacement receipt notices if their employer or DMV is confused.¹¹ The agency can modify the Non-Delivery of Notice e-Request form¹² for this purpose. But to do so, USCIS cannot require noncitizens to assert that their receipt notice was never delivered. Instead, because

immigrants may need an accurate receipt notice to use the automatic extension, the agency should allow applicants to request a new receipt notice if the original incorrectly states that the automatic work permit extension is only for 180 days. If USCIS does not want to use the e-Request form for this purpose, it could establish a dedicated email inbox that renewal applicants could use to request a new receipt notice that properly reflects the 540-day automatic extension. DHS has used dedicated email inboxes to address prior discrete issues. Here, such an inbox could streamline the process of responding to requests and maximize DHS's responsiveness.

2. Explain 540-Day Extension to Employers

USCIS should do outreach to employers and clarify that refusing to honor the 540-day extension may violate the law, which prohibits unlawful employment discrimination on the basis of immigration status.¹³ The TFR acknowledges the related danger that "some employers, notwithstanding possible violation of" federal law, "may be hesitant to hire asylum seekers . . . if it appears maintaining their employment will be difficult due to potential lapses in employment authorization." 89 Fed. Reg. at 24,644-45. USCIS should add such warnings to, at minimum, its "I-9 Central" webpage on Employment Authorization Extensions;¹⁴ its "Information for employers and Employees" webpage about this TFR and the 2022 rule;¹⁵ sections 5.0 through 5.3 of its Handbook for Employers M-274;¹⁶ and its main webpage for Form I-765.¹⁷

3. Amend Form I-9

USCIS should amend Form I-9, Employment Eligibility Verification, and the Form I-9 instructions so that they explicitly account for the 540-day auto-extension. ¹⁸ Currently,

Form I-9 includes several statements that may be confusing for employers considering the TFR. For instance, Form I-9's list of "Acceptable Receipts" that employers may use to verify an employee's work authorization does not currently include the "Notice of Action (Form I-197C)" or "receipt notice." Form I-9 also states that "[a]ll documents containing an expiration date must be unexpired," without any explanation concerning the TFR's auto-extension.

To prevent employer confusion, USCIS should: (1) add the "Notice of Action (Form I-797C)" or "receipt notice" to the list of "Acceptable Receipts;" (2) add a paragraph to the form instructions explaining to employers that an EAD (Form I-766) that is expired on its face is automatically extended for 540 days, and therefore considered "unexpired," when combined with a Notice of Action (Form I-797C) demonstrating that the applicant properly filed a qualifying application to renew their work permit; and (3) in the Form I-9, state "See Instructions for definition of 'unexpired'" immediately underneath the statement "All documents must be unexpired." ¹⁹

4. Conduct Public Engagements with Additional Stakeholders

USCIS should conduct additional public engagements concerning the 540-day automatic extension. For instance, the agency should engage directly with associations of human resources staff, as well as professional employment organizations (PEOs). Additionally, USCIS should post about the automatic extension on social media and create fact sheets, FAQs, and other materials providing a plain-language explanation of the automatic extension process. USCIS should write these materials so that any employer can understand them without the assistance of a lawyer. For example, the agency should explain clearly that even if an EAD appears to be expired on its face, the auto-extension period may apply.

5. Simplify and Improve Upon USCIS Existing Resources

USCIS should simplify and improve upon its existing resources for employers to further minimize confusion, including the Handbook, the Calculator, and website information. In particular, USCIS should update sections 5.0 through 5.3 of its Handbook for Employers to state, more straightforwardly than they do now, that even if a receipt

notice lists an extension of 180 days, an applicant is eligible for an extension of 540 days due to regulatory action, except in certain limited circumstances.²⁰ USCIS should also include a section of the Handbook warning employers that failure to honor the 540-day extension may constitute unlawful employment discrimination on the basis of immigration status. It is difficult to find this information on the I-9 Central website, and employers will likely want reassurance that a 540-day extension is authorized.

6. Update USCIS Calculator and USCIS website

In addition, USCIS should update its Calculator to provide employers with a one-stop, definitive answer as to the expiration date of a work permit. The current Calculator requires an employer to first read a full page of complicated information and decide whether an employee is even eligible for the automatic extension. To reduce the risk of employer mistakes or confusion, a revised Calculator should enable an employer to select or enter all the relevant information (including the EAD category) from an employee's EAD and receipt notice. In addition, the Calculator should include photos and diagrams to show where each piece of information can be found on each document. Once an employer has entered the information, the Calculator should tell them whether the employee is eligible for the automatic extension and exactly when the employee's work authorization will expire.

USCIS should do more to make resources easily available and findable to employers and immigrant workers. For example, the revised Calculator should also be linked prominently on all the webpages discussed above, including the I-9 Central page on extensions, the Information for Employers and Employees page, the Form I-765 page, and the relevant sections of the Handbook for Employers. Additionally, USCIS could post a letter to employers on its website that clearly and succinctly explains the work permit extension and who benefits from it. The letter would ideally be on USCIS letterhead and easy to find on the agency's automatic extension webpage.²¹ Applicants could then print out this letter to provide employers with added assurance.

7. Do More Outreach to State DMVs

ASAP members have reiterated that USCIS should do more to tell states to give driver's licenses to immigrants who have automatic work permit extensions. Unfortunately, despite language in both the 2022 temporary final rule and the current TFR explaining that the automatic extension should be recognized by benefit-granting agencies such as DMVs,²² some DMV employees refuse to accept ASAP members' work permits subject to the 540-day automatic extension as valid identification. This issue is widespread, and not localized to one particular area. Instead, it seems some DMV employees are not aware of work permit extensions bearing on driver's license eligibility, regardless of whether of the length of the extension.

Access to driver's licenses is an issue of particular importance to many ASAP members who need their driver's licenses to work in essential industries such as truck driving, ride-share services, and delivery services. For these members, work authorization is insufficient to keep their jobs if they cannot also renew their driver's licenses.

ASAP commends USCIS for ensuring that the SAVE program will reflect the TFR's 540-day auto-extension, see 89 Fed. Reg. at 24,649 & n.202, and for conducting engagement sessions with DMVs. However, as ASAP members' reports and questions illustrate, these efforts have proven insufficient. Accordingly, USCIS should conduct more extensive engagements with local DMVs to ensure that they are uniformly granting driver's licenses to immigrants with automatic work permit extensions.

C. Let the Auto-Extension Apply to More Immigrants

Although the TFR will bring much-needed relief to many work permit renewal applicants, it leaves thousands of others unprotected. Specifically, the TFR does not apply to individuals whose pending renewal applications were received by USCIS after the expiration dates of their work permits. The TFR frames this limitation as a "timely fil[ing]" requirement, 89 Fed. Reg. at 24,629, but this requirement did not take into consideration a backlog of 16 months or more. See id. at 24,636. And because of

backlogs, individuals who file even one day after their work permit expires are guaranteed to fall out of the workforce for a year or longer.

Many ASAP members have reported that despite their best efforts, they were unable to successfully file renewal applications before their current work permits expired for reasons generally beyond their control, such as the following:

Rejection of timely filings. Some ASAP members applied to renew their work permits before their work permits expired, but their applications were rejected for technical reasons, such as USCIS errors or minor errors of their own (e.g., typos). Once these members were able to refile their applications, their renewal applications could no longer benefit from the automatic extension.

Financial hardship. Some ASAP members report being unable to file for renewal applications before their current work permits expire because they cannot afford the filing fee. For asylum applicants who are filing a work permit renewal, the application fee is \$470 if they can file online, and \$520 if they are applying with a paper application. As USCIS is aware, inflation has created financial hardships for families throughout the United States. Immigrant families are no different. Many ASAP members have explained that they filed for renewal applications as soon as they were able to save enough money for the filing fee, but that if they were not able to save the money before their work permit expired, their applications ineligible for the automatic extension.

Rejection of fee waiver requests. Some ASAP members did not have the funds to pay the filing fee, so they filed renewal applications with fee waiver requests. However, if their fee waiver request was denied, the renewal application was also rejected. Once these members refiled their renewal applications, their applications were no longer eligible for the automatic extension.

Obstacles to immediately filing. Many ASAP members have explained that they filed their work permit renewal applications only a few days after their work permits expired for reasons including cars breaking down, needing to find someone to help them read the document in English, and other obstacles. Because of the backlog, these individuals must now wait for over a year for their renewal applications to be processed. In the meantime, they are left unable to work to support themselves and their families.

A lengthy and more complicated form. USCIS should recognize that the process of applying for work authorization has become significantly more complex in recent years. Again, since 2017, the Form I-765 has grown from two pages to seven pages.

Furthermore, Form I-765 requires that an applicant certify that they speak English, find an interpreter willing to sign and certify that they translated the document for the applicant, or find a preparer. Many renewal applicants have been surprised to encounter such a complex form, causing reasonable delays in their applications.

Accordingly, ASAP urges USCIS to broaden the 540-day automatic extension to apply to any renewal application pending on the effective date of the final rule. Moving forward, we believe the agency should implement a six-month grace period after a work permit expires, during which an individual can apply to renew their work permit and still receive an automatic extension.²³ Given that so many ASAP members and other immigrants report obstacles caused by circumstances outside of their control, these changes would balance the government's interest in addressing the backlog with the economic, social, and humanitarian consequences of unnecessarily depriving people of the ability to work.

VII. DHS Should Make Commenting on Rules More Accessible, Including by Accepting Comments in Languages Other than English

ASAP has attempted to outline ASAP members' primary recommendations and responses to the TFR in this organizational comment. Additionally, ASAP gave members the opportunity to submit their comments to ASAP in their preferred language. Below, ASAP has passed along 165 comments from ASAP members (accompanied by English translations using Google Translate, if written in languages other than English) as part of ASAP's organizational comment.

However, DHS and USCIS should encourage immigrants and asylum seekers to engage in the notice and comment process directly. Consistent with USCIS's mission statement of ensuring "fairness, integrity, and respect for all we serve," ²⁴ DHS and USCIS should seek out guidance from ASAP members and other directly affected individuals, and the agencies should give their insights serious consideration. Based on their firsthand experience navigating the immigration system, ASAP members have a wealth of knowledge about how to improve the system—knowledge from which the government would significantly benefit.

To that end, DHS and USCIS should improve the notice and comment process with the goal of encouraging immigrants and asylum seekers to comment. At minimum, to make the process more accessible, DHS and USCIS should translate requests for comment into multiple languages and clearly state that they will accept comments in languages other than English, beginning with accepting comments in Spanish.²⁵

VIII. Conclusion

ASAP commends DHS for ensuring that 800,000 immigrant workers do not lose their jobs due to work permit backlogs. By issuing the TFR, DHS has provided much-needed stability and security to many asylum seekers and other immigrants, their employers, and local communities across the United States. At the same time, for the same urgent reasons that prompted DHS to issue this TFR, DHS and USCIS must undertake significant additional steps—this year—to avoid hundreds of thousands of immigrants falling out of the workforce. Chief among these changes, is lengthening the work permit extension period to 730 days.

USCIS should also make eliminating the work permit processing backlog a top priority for this calendar year. Indeed, failure to timely process work permit renewal applications could expose USCIS to legal liability, as governing regulations contemplate that "application[s] for [work permit] renewal . . . received by [USCIS] 90 days prior to expiration" will be "renewed before [their] expiration." 8 C.F.R. § 208.7(d).

ASAP respectfully recommends DHS implement the following changes to mitigate harm to applicants:

- (1) DHS should make the TFR permanent;
- (2) DHS should lengthen the auto-extension period to 730 days; and
- (3) USCIS should prioritize work permit processing, take additional steps to alleviate confusion around the TFR amongst employers and DMVs, and expand the number of immigrants covered by the TFR.

Finally, DHS and USCIS should make the notice and comment process more accessible for asylum seekers and immigrants, including by translating requests for notice and comment and allowing individuals to submit responses in languages other than English, beginning with Spanish. To that end, following this page are 165 comments submitted by ASAP members, who shared their views on the TFR in Arabic, Chinese, English, French, Kreyol, Russian, and Spanish. ASAP urges DHS to give these comments careful consideration, as they are from individuals who themselves have navigated the work permit renewal process.
